UKIP wants a

We want the **FULL ENGLISH**, bangers and all (including for Northern Ireland!).




Specifically we want:


- To reduce and eliminate the massive trade deficit with the EU, now running at over £120bn a year, 6% GDP, which has been undermining our economy as it has built up over the past twenty years,
- An independent fishing quota system for British waters that gives UK vessels first bite at the cherry, ends
 discarding, excludes super-trawlers and auctions off the balance to foreign vessels regardless of nationality,
- The recovery of our sovereignty in Northern Ireland,
- The recovery of our sovereignty over human rights.

To do this we shall have to

DECLARE ECONOMIC WAR ON BRUSSELS.

There is little chance they will come back to the negotiating table, and in any case UKIP has always advocated a **NO DEAL** solution. Now you can see why! Look at the two graphs below. The first shows our balance of payments split between the EU and other countries. You can see that whilst our trade with the EU has plummeted, that with the rest of the world has moved solidly into surplus. There is only one way such a divergence could have happened. Over that period of time Brussels has been surreptitiously, assiduously, persistently and maliciously piling up non-tariff barriers against our exports. The thieving bastards have been **STEALING OUR MONEY**, and our dozy officials in London have not even noticed. The EU has been treating us as a **CASH COW** for far too long, but now the time has come to **KICK OVER THE PAIL**.





If you present British business with an increasing trade deficit like this you are presenting us with a contracting market as people buy more and more foreign stuff and less and less British stuff. Jobs are lost left right and centre, but more than that, business will not invest into a contracting market. They need the increase in turnover to carry the new investment which then in turn carries the productivity which provides the economic growth. You can see the effect from the second graph of GDP per capita annual growth rates. In 1999 it was 2.8%, but by 2019 it had shrunk to just 0.7%. The big downward spike in the middle is the banking crisis, but what is interesting about that is that it bounces straight up again onto its previous trend line and then carries on just as before. So don't let them tell you the productivity gap is caused by the banking crisis. It's not. It is solely due to our trade deficit with the EU. Many jobs have been replaced by intensive

fiscal and monetary stimulation, but at a cost of record levels of national debt and record levels of personal debt. That is simply not sustainable.

Also do not let them tell you we could not win an economic war against Brussels because they are so much bigger. Size is irrelevant (the rest of the world is bigger still and yet we trade at a surplus with them). It's balance that matters. Think it through. What is the worst that could happen? Zero trade in both directions. That would mean the EU loses the massive surplus they are looting from us. But the UK economy would benefit from a huge injection from import substitution, and any goods or services we still cannot make ourselves we can source at no extra cost from the rest of the world. And just to add an extra twist, we can finance the tariffs our EU export customers will have to pay out of our own, higher import tariff revenues, so our exports can carry on unaffected. And that is entirely legal under WTO rules!

As Churchill might have put it: "We shall fight them on our fishing grounds, we shall fight them at our ports, we shall fight them in the media and in the courts. We shall *never* surrender". In fact it will be a walk in the park. We have them by the short and curlies! **LET US PRIZE THEIR THIEVING STICKY MITS OFF OUR MONEY.**

ON IMMIGRATION UKIP WANTS

- A QUOTA system for legal immigration, set at 50,000 a year less than the number who quite voluntarily and of their own free will emigrate each year. A points based system is not even designed to limit total numbers; only those who end up on benefits, and in any case it is easily gerrymandered by Big Business. Open borders have in recent years caused immense damage to this country economic, environmental, housing, public services and , yes, cultural displacement. It is not enough to acquiesce in reducing to the tens of thousands; we have actually to reverse the process to repair the damage. The Tories are not serious about immigration. Only UKIP cares.
- An overseas colony solution for illegals and refugees. The Danes have already started to do this and we can take
 it further with an open, civilised, prosperous colony that can be an economic benefit to the host country as well
 as provide a decent and safe standard of living for its inhabitants under British sovereignty and rule of law.
 Meanwhile Priti Patel just stands there, like King Canute, waving them back to the last safe country they crossed!

BEYOND BREXIT UKIP WANTS

- Equality under the law and a determination to bring all criminals to justice regardless of their religion
- Free speech including the encouragement of minority and oppressed groups to speak up and tell us like it is from their point of view. We oppose the cancel culture and woke disciplinary procedures, and UKIP's Party Constitution has always opposed all forms of discrimination. We have no problem with diversity, but do have one with cultural displacement; the rate of change in diversity. No one wants to be displaced within their own country and every group wants to celebrate and preserve its own culture. All groups must be sensitive and not over-assertive to those others around them. This is a moral issue and should not involve the law in a free society.
- Social Libertarianism, to reduce the size and scope of government and taxation without endangering a reliable
 welfare state, an effective regional policy and first class essential services such as health and education free for
 all, thereby promoting equality of opportunity across the land. This will require a focus on efficiency and
 alternative sources of finance such as a Sovereign Wealth Fund, means-tested access for all to the private sector
 for essential services, and some proper top management for public services separated from the Civil Service and
 accountable directly to the relevant ministers.
- **Environment**, including a balanced approach to climate change to ensure we don't destroy the economy in the process and do provide an optimum balance between protection and prevention; protection at our sewage works to prevent overflows from excess demand into our rivers, and a reversal of the lunatic tip charges policy which is creating fly-tipping havoc across the land.
- Education reform, to ensure no child is left behind by providing greater funds for the slower streams.
- Create a centre, radical social libertarian party to replace the Dinosaur parties.
